Some argue amalgamation is needed to achieve regional projects such as the long-awaited pool, give business a boost, and market the region to the outside. Others counter that the region's seven townships work co-operatively already with a track record of affordable tax rates.

Parry Sound-Muskoka MPP Norm Miller said municipal governments are efficient and didn't tout the Muskoka format of a regional upper-tier government but said the lack of a single entity keeping an eye on regional projects is a barrier to moving ahead.

Friends of the Massasauga Park Updates

Since the arrival of the new government in Ontario, Ontario Parks (which manages the Massasauga Park) now falls under the newly organized Ministry of Environment, Conservation and Parks. Their funding has been frozen since June.

At a recent meeting, the Friends of Massasauga Park, with the support of South Channel, agreed to back exploring the possibility of developing a new trail in the north part of the Park near Devil's Elbow. Park staff have indicated that this would need to be supported and cared for entirely by the Friends. (Friends already look after the trails at Moon Island, Wreck Island and Baker Trail and have provided trail markers for all three.) Initial research is underway to see whether a 4 km trail in this area would be viable. *Would people from Sans Souci be interested/use a trail in this area?* Below is a quick survey to gauge interests. If initial research is supportive of moving forward, some fundraising as well as volunteer participation may be needed to prepare the trail. Stay tuned!

Microfibres in the Great Lakes

*An excerpt from Lisa Erdle's article in Georgian Bay Forever's Winter 2018 issue

Microfibres (ers) are some of the most common microplastics in the Great Lakes. Derived from synthetic textiles (e.g. polyester, acrylic, polypropylene, polyamide and polyethylene), microfibers may enter the environment in many ways.

One known pathway is shedding from clothing, with studies on synthetic textiles showing that some articles can shed 100,000 microfibers in a single wash. While wastewater treatment plants (WWTPs) may capture up to 90% of microfibers entering these facilities, a recent study in the United States showed that a single WWTP can discharge up to 5 million microplastic particles per day, even when serving catchment areas of around 100,000 people.

And with approximately 34 million people living in the Great Lakes Basin, the total load of microfibers entering natural waterways is substantial.
